WRITS OF EXECUTION

This is not a legal interpretation of the rules and regulations on writs of execution. We refer you to the Federal Rules of Civil Procedures for specifics.

If the judgment is rendered in the Northern District of Oklahoma and you request the Court in the Northern District of Oklahoma to issue the writ of execution, there will not be a charge.

In the Northern District of Oklahoma, once a judgment is on file, the suggested procedure to apply for writs of execution is:

- 1. Please file a motion, if appropriate (e.g. Federal Party) and a completed, proposed writ of execution form to the Court. A sample writ is attached as Exhibit A.
- 2. If the U.S. Marshal is to seize a specific piece of property such as livestock, cars, machinery, inventory, bank accounts, etc., you must put specific information in the Special Instructions section on the USM-285 form. A sample USM-285 form is attached as Exhibit B. You must also be prepared to accompany the U.S. Marshal when the property is to be seized.
- 3. If the U.S. Marshal serves the writ of execution, there will be a charge for service, mileage, mailing, storage, moving and miscellaneous expenses where applicable.
